**KEPERLUAN PERJANJIAN ANAK BUAH KAPAL DAN PEMBERITAHUAN SIGN ON/OFF
CREW AGREEMENT AND NOTIFICATION OF SIGN ON/ OFF REQUIREMENT**

Sukacita diperingatkan kepada Pemilik, Syarikat Pengurusan, Agen Perkapalan dan Nakhoda Kapal berkenaan dengan perkara berikut:

Perjanjian Anak Buah Kapal

Kapal-kapal bertanan kasar 25GRT dan ke atas adalah dikehendaki mengikut Seksyen 57, Perintah Perkapalan, 2002 memiliki perjanjian anak buah kapal.

Jika kapal tersebut belayar atau cuba untuk belayar tanpa mematuhi kehendak kehendak seksyen berkenaan, Nakhoda kapal atau majikan anak buah kapal boleh dikenakan denda sehingga \$5,000 dan kapal mungkin ditahan.

Pemberitahuan Sign on/ sign off

Semua anak buah kapal yang hendak sign on/ off kapal adalah dikehendaki untuk memaklumkan kepada Pengarah Laut mengikut Peraturan (4)(1)(b) Merchant Shipping (Crew Agreement, List of Crew and Discharge of Seamen) Regulations, 2007. Sesiapa yang gagal mematuhi kehendak peraturan ini adalah didapati bersalah dan boleh dikenakan denda tidak melebihi \$500.

This is to remind all Shipowner, Ship Management, Shipmaster, Shipping Agents and Shipping community regarding the following:

Crew Agreement

Any vessel of 25GRT and above is required by Section 57 of The Merchant Shipping Order, 2002, to have a crew agreement onboard in form prescribed by the Director.

If a ship goes to sea or attempts to go to sea in contravention of the requirements of this section, the master or the person employing the crew of the ship shall be guilty of an offence and liable on conviction to a fine not exceeding \$5,000, and the ship may be detained.

Notification of Sign on/Sign off

The Master or employer shall, as per Regulation (4)(1)(b) of the Merchant Shipping (Crew Agreements, List of Crew and Discharge of Seamen) Regulations, 2007, notify the Director any engagement or discharge of crew from ship. Any person who fail to comply with the requirement shall be liable to a fine not exceeding \$500.
